❖ **Online banking:**

- Add Cherry Creek Waterworks as a payee.
 - For Quarterly Water Tolls use your account number **only** (ex.10101).
 - **For Parcel Tax, use your account number Plus a P on the end** (ex. 10101P).

❖ **Cheques** can be put into our mail slot at the office. Please do NOT put CASH in the mail slot.

❖ **Debit/Cheque/Cash** in office.

❖ **Pay at your bank.**

At the Cherry Creek Waterworks office, water bills are sent out quarterly. **Expect a water bill to be due at the end of March, June, September, and December.** Parcel tolls also are due at the end of September.
